Where Are the Missing Falun Gong Practitioners?



(Clearwisdom.net) The following Falun Gong practitioners are just a few of many who have been missing during the past 6 years of persecution in China.

Jin Yan from Jilin City has been missing since 2002

Jin Yan, female, 48 years old, is from Jilin City, Jilin Province. On April 1, 2002 she went to Beijing to appeal on behalf of Falun Gong. Ever since then, her whereabouts have been unknown.

Zhang Wenliang from Zunhua City, Hebei Province, went to Beijing to appeal in 2000, has not returned

Zhang Wenliang, male, born in October 1945, is from Zunhua City. In early November 2000, he went to Beijing to appeal for justice for Falun Gong but has not returned since then.

Li Ruihuan from Shijiazhuang City has been missing for over 4 years

Liu Ruihuan, female, in her 60's, is from Shijiazhuang City, Hebei Province. Her address is 42-5-301, the Huaxing Neighborhood. On January 13, 2002, she went to Beijing to appeal on behalf of Falun Gong. The police arrested and severely beat her and placed her in the Fengtai Detention Center. Her current whereabouts are unknown.

Anshan Detention Center in Liaoning Province formerly imprisoned many practitioners who refused to tell their names; they are now missing

To resist the persecution and avoid the policy of implicating and pressuring family members, friends and work units, many practitioners who went to Beijing to appeal for Falun Gong refused to give their names and addresses to the authorities when they were arrested. Therefore, the local liaison offices in Beijing and practitioners' family members often went to the detention centers in Beijing to look for those whom they knew. Once they found the practitioners from their local areas, the practitioners would be brutally beaten. Local police then took those practitioners back to their hometowns, where they would be subjected to even more severe persecution.

However, there were still many practitioners at the Anshan Detention Center who did not tell their names, and their whereabouts are unknown. We do not know their current circumstances, or whether any of them have been transferred to the Sujiatun Concentration Camp and murdered.

Introduction to Falun Dafa

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. The practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-

Forbearance in daily life. Falun Gong is not only beneficial to one's own health and well-being, it also benefits others. Although the practice originated in China, today it is practiced throughout the world by people of all races and walks of life. In the face of the most brutal vicious and persecution perpetrated on them by the Chinese Communist Party, Falun Gong practitioners have found the spiritual strength to resist peacefully and tirelessly by upholding the principles of Truthfulness-Compassion-Forbearance.

US Congressman Rohrabacher:

"It's time for the civilized world to say 'no' to the monsters that are tearing apart people in China"



(Clearwisdom.net) When interviewed about the atrocities occurring in secret Chinese concentration camps, US Congressman Dana Rohrabacher stated, "This is gruesome and clearly beyond the moral standard of almost every country that I know. It's time for civilized world to say 'no' to the monsters that are tearing apart people in China." Rohrabacher called for an investigation and for making the truth known to the people of the world.

Rohrabacher said, "We have a responsibility to have our President express America's strong wish to have a full investigation of these charges and demand an explanation from Chinese leader Hu Jintao during his upcoming visit and an agreement to allow on-site third-party investigations. I think you will agree this is the least we can do."

Rohrabacher noticed the surge of organ transplant centers in the past few years in China, and said, "On the website for the just one transplant center, the Oriental Organ Transplantation Center in Tianjin (www.ootc.net), we could see a graph of their 'achievements' shows the number of procedures growing by leaps and bounds after 1999, the year the persecution of Falun Gong officially began."

Ms. Chen Xingtao Died after Torture at the Baimalong Forced Labor Camp in 2002 *Her Family Seeks Justice*

(Clearwisdom.net) 39-year-old Falun Dafa practitioner Ms. Chen Xingtao passed away in May 2002, after being savagely tortured at Baimalong Forced Labor Camp in Zhuzhou City, Hunan Province. In the past four years, her husband Li Yuejin has gone to various government departments to seek justice. On July 12, 2004, Li Yuejin filed a lawsuit against the Baimalong Forced Labor Camp and asked for the guards at the labor camp and their superiors to be held accountable for their crimes, because as administrators of the law they have violated the law. He also asked for the defendants to pay for the expenses incurred from Ms. Chen's injuries and death, as well as to help with the rearing of their children.

Falun Gong at the Washington, DC Cherry Blossom Festival

Visitors filled the area near the Jefferson Memorial and watched the multicultural performances on a stage near the Reflection Pool. Falun Gong practitioners from Washington, DC were invited to perform on the stage. Many visitors took flyers introducing Falun Dafa and exposing the concentration camps in China, where Falun Gong practitioners' organs were harvested while the practitioners were still alive and the bodies cremated. Visitors were shocked to learn of this and couldn't believe that practitioners of such a peaceful and beautiful exercise are so cruelly persecuted in China. Some visitors said that they would tell more people and would contact the White House and Congress to ask the United States government to help end the persecution.
