### Health, Ethics and Human Rights Seminar in Switzerland Focuses on the Chinese Organ Trade

(Clearwisdom.net) During the first conference of the UN Human Rights Council, a health, ethics and human rights seminar was held at the UN Office in Geneva on June 29. The seminar focused on the illegal organ trade in China and called for an independent investigation into the situation so as to end the inhuman crimes.

Dr. Charles Graves, chairman of Interfaith International hosted the conference. Targeting the allegations of organ removal from living Falun Gong practitioners in China, he made the point that the new human rights council should pay attention to the issue.

Ms. Chen Ying, a Falun Gong practitioner who was illegally held in a detention center and forced to do hard labor, told of her experience of being forced to undergo a health checkup, then being injected with drugs that caused extreme pain, nerve damage and memory loss. In light of the recent exposure of the organ trade in China, she believes that the authorities "...were in all probability prepared to use drugs to destroy my nervous system and then would take me somewhere to have my organs removed."

Chairman of the International NGO Human Rights Special Committee, Mr. Peter Prove indicated that the reports and the experiences of the victims help him to realize that the value of the fundamental dignity of human beings has been attacked.

Mr. Thomas Buchi, the former chairman of the Human Rights Committee in the Parliament of Geneva said, "I am horrified at such a wild action, like that of the Nazi doctor Mengele. We should report the above to the Human Rights Council and Ms. Louise Harbor, High Commissioner of Human Rights at the UN so as to stop the wild infringement of human rights."

## Falun Dafa Practitioners Tortured at Shijiazhuang Fourth Prison

(Clearwisdom.net) The guards at Hebei Province Fourth Prison torture Falun Gong practitioners day and night. They are awarded 2,000-8,000 yuan for making each practitioner renounce Falun Gong.

1. From February to October of 2005, practitioner Mr. Zhang Huiguang was tortured to the point of being incontinent. This year, Mr. Zhang went on a hunger strike to protest the inhuman abuse and was force-fed by guards. Feeding tubes were inserted into both of his nostrils. People who had been released from prison said, "Mr. Zhang Huigang was severely tortured."

Zhao Wenzhong, head of Ward 9, is directly involved in torturing Mr. Zhang. Someone witnessed him torturing a Falun Gong practitioner to death. Zhao was promoted to Deputy Section Chief because he does his utmost to persecute Falun Gong practitioners.

## Senior Medical Doctor Witnesses the Miracles of Falun Dafa

(Clearwisdom.net) I personally witnessed the magnificence of Falun Dafa. I worked as a senior supervisor in the gynecology and pediatrics departments of a city hospital for nearly 20 years. After my normal working hours, many patients from poor families came to visit me for acupuncture treatments. I usually did this for free and gave those poor patients medicine. However, my health soon collapsed. I suffered from various diseases such as bronchitis, a gastric ulcer, neuralgia, insomnia, high blood pressure, congestive heart failure, and stroke. I visited all the well-known hospitals in the nation, but still failed to find any cure. Getting my heart condition evaluated cost me about US\$4,000. My health continued to deteriorate.

When I had no other alternatives, one of my supervisors at work, a person that had once suffered and had recovered from diabetes, high blood pressure, stroke, and a bone spur, gave me the book *Zhuan Falun* (the principal text of Falun Gong). I began practicing Falun Gong. In less than two months, all my diseases unbelievably vanished. Many of my patients with difficult diseases recovered by practicing Falun Gong, too. One of the patients suffered from heart disease and another suffered from uremia. Other diseases that disappeared included femoral head necrosis, paralysis, leukemia, a three-inch uterine tumor, breast cancer, kyphosis, Hepatitis B, rheumatic and rheumatoid diseases, lupus, refractory dermatitis, tinea, and asthma. How magnificent Falun Dafa is!
