Evidence of the Chinese Embassy in Canada Interfering with NTDTV

(Clearwisdom.net) On April 4, 2007, Ms. Zhang Jiyan, the wife of a Chinese diplomat at the Chinese Embassy in Canada, exposed a document to the media. The document showed that the Chinese Embassy in Canada tried to interfere with NTDTV's application to the CRTC (Canadian Radio-television and Telecommunications Commission) for a permit to air in Canada. NTDTV is an independent media and is not controlled by any government. NTDTV has reported on such issues as the real situation of SARS in China in 2003, the CCP's persecution of Falun Gong and other religious beliefs, and other human rights issues in China. The president of NTDTV Canada Wang Shaojiu said, "The CCP has tried its best to attack and suppress media outlets like NTDTV. The CCP has been trying to undermine the operations of NTDTV, a legal enterprise in Canada, and now we have evidence, with names of the CCP officials who are involved.

Ms. Zhou Limin, a spokeswoman for the Falun Dafa Association in Canada, said that the document verified that the Chinese Embassy has been systematically persecuting Falun Gong. According to Ms. Zhang Jiyan, the document said that the CCP's Department of Foreign Affairs ordered the Chinese Embassy to keep Chinese people from supporting NTDTV's Chinese New Year Galas. Another document showed that the Chinese Embassy tried to lobby the Canadian government to stop NTDTV from entering Canada, and incited the local Chinese communities and Chinese students to write to the government against NTDTV.

One of the documents that Ms. Zhang has is an official document entitled, "Results of the Investigation of NTDTV Trying to Enter Canada and the Results of the Lobbying Work." Huang Huikang, the Minister Counselor and Consul General, wrote personal notes on the document on March 25, 2003. A second document written by Huang Huikang was a brief report and working plan, for an embassy official. Huang said in the document: "According to the information I got, it is possible for us to destroy NTDTV's plan of entering Canada. I will take more actions."

Ms. Zhang said that there is a "Political Research Office" consisting of ten staff members at the Chinese Embassy. The task of this office is to deal with democratic movement activists, Falun Gong, Free Tibet organizations and Taiwan independence movement activists. Huang Huikang is in charge of persecuting Falun Gong while denying the persecution to the Canadian media. "The Chinese Embassies are the bases for the CCP to persecute Falun Gong outside China. The orders are issued by the Department of Foreign Affairs," said Ms. Zhang.

Ms. Zhou Limin said, "Although the document only shows how they interfered with the operation of NTDTV, we can tell that the persecution of Falun Gong overseas has been systematic, well-organized and well-planned for a long time." "The Chinese Embassy creates blacklists of Falun Gong practitioners, taps their phones, harasses them and attacks them. In 2005, the Edmonton Police Service hate crimes unit testified that the diplomat at the Consulate in Calgary spread materials to incite hatred toward Falun Gong. In 2004, Pan Xinchun, the Chinese Deputy Consul General in Toronto, was found guilty of libel by the Ontario Superior Court in Canada."

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. Introduced by Mr. Li Hongzhi in China, the practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-

Spanish People Support 20 Million Withdrawals from the CCP

(Clearwisdom.net) At 4 p.m. on March 31, 2007, a banner in Chinese and Spanish reading, "Global support for the 20 million people withdrawing from the Chinese Communist Party (CCP)" was displayed at Puerta del Sol, a plaza in central Madrid. The banner was part of a rally organized by volunteer workers of the Spanish Service Center for Quitting the CCP, to support the 20 million Chinese people withdrawing from the CCP.

Throughout the activity, more and more people gathered to view the display boards exposing the Chinese Communist regime's atrocities against Falun Gong. There were people condemning the atrocities and expressing their support for the campaign against the persecution. They asked for flyers and inquired as to how they could help the innocent people being persecuted in China. Upon hearing that signing the petition could help stop the persecution, they came forward to sign their names. After signing the petition, a mother told her son and other four children about what is going on in China. These children also signed the petition.



Passerby were interested in finding out about the persecution against Falun Gong from the display boards, and waited in line to sign the petition to support the 20 million withdrawals from the CCP.

Many Chinese people attentively viewed the display boards. A young Chinese angrily said, "It is the CCP's corruption, bullying civilians and persecuting innocent people that makes Chinese people feel ashamed in foreign countries. The CCP's autocracy has destroyed the 5,000-thousand year traditional Chinese culture and its moral standards." Pointing to a photo showing a Chinese policeman administering cruel torture against a Falun Gong practitioner, a man said, "The CCP is just like the Nazis of the past, or even crueler than the Nazis."

Before the activities came to a close, a young woman from Peru talked to a volunteer worker. She said, "I wish you great success. Keep persevering! Success is not far away."
