### Seven Years Later, Still No Justice for Falun Gong Practitioner Who Died in Police Custody

(Clearwisdom.net) Seven years ago, Ms. Li Shuhua, a 32-year-old Falun Gong practitioner from Yushu City, Jilin Province, died just 14 days after she was arrested. Those responsible have yet to be brought to justice.

Ms. Li was a seamstress. Her husband Mr. Yang Zhanjiu and mother Ms. Cui Zhanyun, both Falun Gong practitioners, were arrested in 2002 under the Chinese Communist Party's persecution of Falun Gong. Ms. Li and her two young children went to live with her father. On September 24, 2003, three officers from the Yushu City Police Department went to Ms. Li's home and forcibly took her away. They claimed that they would let her return home within 20 minutes. Two days later on September 26, the police sent a detention certificate that gave no reason or terms for her illegal detention.

Ms. Li was beaten to death on October 7, yet the police did not notify the family until October 9. When her family asked how Ms. Li died, the police said it was due to a hunger strike. Later, a police officer who knew the details told the following story.

After the arrest, Li Shuhua was held at the Yushu City Detention Center. When she refused to answer a police interrogation, several police officers started to torture her. They put a plastic bag over her head and used needles to prick her fingertips, arms, back, and chest. Ms. Li cried out because of the pain. Several inmates and staff members reported hearing her being tortured.

A police officer demanded that Ms. Li give the names of her associates and the sources of her Dafa materials [referring to printed informational materials that Dafa practitioners distribute to explain the facts about Falun Gong and expose the persecution]. When she kept silent, the officer hit Ms. Li so hard in the eye that her eyeball was knocked out. Ms. Li was in excruciating pain and immediately fainted. The officers became frightened, because this would be hard to explain to her family and the public. After discussing this with their supervising officials, the officers were told to kill Ms. Li to cover up the crime. A former inmate confirmed that on October 7, 2003, in the Yushu City Detention Center, Ms. Li was taken away by several people. The inmate heard Ms. Li screaming. She never returned to her cell.

The officers took Ms. Li's body to a hospital where it was soaked in chemicals for several days followed by cosmetic treatment, including freezing, to make the needle holes in her body less visible. Yet, one side of her face was bluish, and during the autopsy, her family saw that her facial skin was lacerated, her nails were bluish and her abdomen was full of blood.

Ms. Li's family has tried to bring those responsible to justice. Her husband Yang Zhanjiu submitted a letter of indictment to the leader of the Jilin Province Public Security Bureau. Yang said, "So far I have not heard a reply."

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. Introduced by Mr. Li Hongzhi in China, the practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-Forbearance in daily life. Falun Gong is not only beneficial to one's own health and well-being, it also benefits others. Although the practice originated in China, today it is practiced throughout the world by people of all races and walks of life. In the face of the most brutal and vicious persecution perpetrated on them by the Chinese Communist Party, Falun Gong practitioners have found the spiritual strength to resist peacefully and tirelessly by upholding the principles of Truthfulness-Compassion-Forbearance.
